I forwarded your email to Division of Energy, Minerals, and Land Resources, Land Quality Section Chief, Toby Vison, PE. I also have forwarded it to Judy Wehner, Assistant Mining Specialist.

I have quickly reviewed the file and the last inspection was conducted 9-25-2012, by Matt Gantt PE, Winston Salem Regional Office Land Quality Regional Engineer, and myself. The site was noncompliant during our inspection. After the inspection, Matt and I decided that we should request additional support from the Raleigh Central Office during our inspections for safety. During the inspection Mr. Cecile displayed a firearm to us. The site has not been inspected since that day.

A permit modification has been submitted to Raleigh Central Office, and our office received it for review on 8-03-2015. Matt Gantt, and Scott Sink completed the review and sent the comments to Raleigh staff, Janet Boyer, PE, Mining Engineer, and Judy Wehner, Mining Assistant and are part of the file.

I will consult with Matt, and we will plan an inspection to follow up with your concerns.
